- B. Bride and everyone receiving services agrees to appoint Southern Tease to provide hair and/or makeup services on the date and time agreed.
- C. Southern Tease agrees to perform these services for bride and wedding party under the terms and conditions set forth in this contract.

### COMMITMENTS

#### SOUTHERN TEASE OBLIGATIONS

- A. Southern Tease will provide service(s) with reasonable care and skill while using their own products.
- B. Southern Tease will perform the service(s) promptly on the date and time agreed.

#### BRIDE OBLIGATIONS

- A. Bride is responsible for Southern Tease fees, assistant fees, parking and travel fees.
- B. Bride agrees to immediately inform Southern Tease and assistants on location AND in this contract of any sensitivities or allergies **anyone receiving services** may have to any types of makeup, skin care, hair products, chemicals or treatments.
- C. Inform us of any and all allergies or sensitivities before date(s) of services.
- D. Bride is required to notify Southern Tease of a final count of services **at least 60 days before** her wedding day or she will still be charged for those services.
- E. In the case of a returned check, there will be an additional \$50.00 charge
- F. In order to perform hair services all **hair must be dry** prior to getting hair done.
- G. In order to perform makeup services, client's **face must be free of any and all makeup products.**

## PAYMENT

### DEPOSIT

Bride is required to pay Southern Tease a total of eighty dollars in order to officially book her wedding date. The eighty dollars will go towards her service(s) on her wedding day. In the case of cancellation, the deposit is **non-refundable**.

### FORM OF PAYMENT

Cash, checks, or credit cards are acceptable. However, there will be an additional 5% of your total added as a processing fee for credit cards.

### TRAVEL

Travel fees will be discussed at booking and are required to be paid for by the bride.

### TOUCH UPS

If bride desires Southern Tease to stay after initial service(s) for touch ups, there will be an additional fee of \$100 an hour per stylist.

## CANCELLATION POLICY

- A. If **any** services are canceled 60 days or less before the wedding, the **Bride** is still obligated to pay for those services.
- B. In the case of a cancellation, the deposit will not be refunded for **ANY** reason.

## LIABILITY

Southern Tease is not legally liable or responsible for allergic reactions, injuries, losses, damage, costs, claims, and/or actions that may occur to the bride or bridal party.
